Food, Shelter & Employment - Provides information and referral, connection with community resources, collaborative problem solving, and direct financial assistance to families dealing with financial emergencies that threaten their ability to meet their basic needs. Food and Shelter also serves as an access point to services such as the food pantry, low interest loans, legal support, budgeting, financial planning, and others.
