The program promotes health, wellness, mobility, and self-efficacy.

4b (Code:) (Expenses \$ 1,419,357. including grants of \$ 972,749.) (Revenue \$) Food Pantry - Assists families and individuals in need of essential food items such as grains, dairy, protein, as well as fresh fruits and vegetables. The Pantry offers both VAAD-supervised kosher and non-kosher food items.

4c (Code:) (Expenses \$ 1,367,058. including grants of \$ 843,090.) (Revenue \$ 4,095.) Food, Shelter & Employment - Provides information and referral, connection with community resources, collaborative problem solving, and direct financial assistance to families dealing with financial emergencies that threaten their ability to meet their basic needs. A range of funds allows strategic financial assistance directed to help families get back on their feet. Food and Shelter also serves as an access point to services such as the food pantry, low interest loans, legal support, budgeting, financial planning, and others.
